OF
PETERSON'S GUIDES INC.

The undersigned corporations, pursuant to Section 607.1107 of the Florida Business Corporation Act hereby executes the following Articles of Merger:

FIRST: The names of the corporations proposing to merge and the names of the states or countries under the laws of which such corporations are organized are as follows:

<u>Name of Corporations</u>	<u>State of Incorporation</u>
Peterson's Guides Inc.	New Jersey
Thomson Information Inc.	Florida

SECOND: The laws of the state or country under which such foreign corporation is organized permit such merger and such foreign corporation is complying with those laws in effecting the merger.

THIRD: The foreign corporation complies with Section 607.1107 F.S. and the surviving domestic corporation complies with the applicable provisions of Sections 607.1101 - 607.1105 F.S.

FOURTH: The plan of merger is as follows:

1. Thomson Information Inc., a corporation organized under the laws of the State of Florida, shall merge with and into itself and assume the liabilities and obligations of Peterson's Guides Inc., a corporation organized under the laws of the State of New Jersey. The name of the surviving corporation is Thomson Information Inc.

2. All of the issued and outstanding shares of stock of Peterson's Guides Inc., which are owned by Thomson Holdings Inc., the sole shareholder, shall be surrendered and cancelled in exchange for one share of stock of Thomson Information Inc., the surviving corporation.

3. The Articles of Incorporation of Thomson Information Inc. shall be the Articles of Incorporation of the corporation surviving the merger. No changes or amendments shall be made to the Articles of Incorporation because of the merger.

4. The by-laws of Thomson Information Inc. shall be the by-laws of the corporation surviving the merger.

5. The directors and officers of Thomson Information Inc. shall be the directors and officers of the corporation surviving the merger and shall serve until their successors are selected.

6. The officers of each corporation party to the merger shall be and hereby are authorized to do all acts and things necessary and proper to effect the merger.

FIFTH: The effective date of the merger shall be the 31st day of December, 1995.

SIXTH: The plan of merger was adopted by the shareholders of Peterson's Guides Inc., on the 31st day of December, 1995, and was adopted by the shareholders of Thomson Information Inc. on the 31st day of December, 1995.
