TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Trademark Release") is dated as of December 17, 1998, by Harris Trust and Savings Bank (the "Lender") in favor of Roman Adhesives, Inc. (the "Borrower");

WHEREAS, the Borrower entered into a certain agreement (the "Trademark Agreement") which was recorded with the United States Patent and Trademark Office on February 9, 1990 at Reel 0689, Frame 0076 for the purpose of securing the obligations owed to the Lender pursuant to a lending arrangement between the Lender and the Borrower;

WHEREAS, pursuant to the Trademark Agreement, the Borrower granted to the Lender a collateral security interest in all of the Borrower's Trademarks, as defined in the Trademark Agreement, including, without limitation, the Trademarks identified on Exhibit A attached hereto, and the goodwill of the Borrower's business connected with the use of and symbolized by the Trademarks (collectively, the "Trademarks"); and

WHEREAS, all of the obligations owing to the Lender under the lending arrangement have been paid in full prior to the date hereof and the Lender has agreed to terminate and release its security interest in the Trademarks as herein provided;

NOW THEREFORE, for valuable consideration and pursuant to the terms and conditions of the lending arrangement between the Lender and the Borrower;

Lender hereby terminates and releases its security interests in the Borrower's Trademarks, including, without limitation, the Trademarks identified on Exhibit A attached hereto, and the Lender hereby assigns and transfers to the Borrower, all of the Lender's

right, title and interest in and to the Trademarks, including, without limitation, the Trademarks listed on Exhibit A attached hereto, effective as of the date set forth above.
