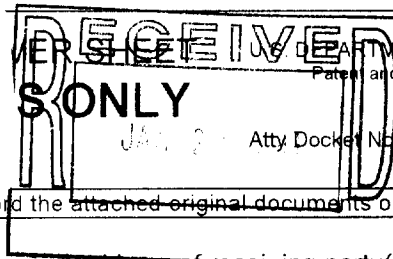

ASSIGNMENT


