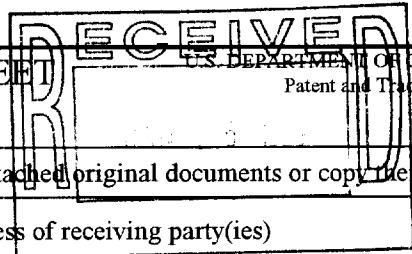

ASSIGNMENT

WHEREAS, AMERICAN HOME PRODUCTS CORPORATION ("AHPC"), a corporation organized and existing under the laws of the State of Delaware, having an address at Five Giralda Farms, Madison, New Jersey 07940, is the owner of record of the United States trademark identified in Schedule A set forth below (hereinafter, the "Trademark") and of the applications therefor and registrations thereof in the United States Patent and Trademark Office as set forth in Schedule A below;

WHEREAS, on February 20, 1998, AHPC entered into an Agreement with Zeneca Limited ("Zeneca"), under which AHPC is to assign the Trademark to Zeneca or Zeneca's nominee on or before June 30, 1998; and

WHEREAS, Zeneca has nominated CAMBRIDGE SELFCARE DIAGNOSTICS LIMITED ("CSDL"), a corporation organized and existing under the laws of England, having an address at Richmond House, Old Brewery Court, Sandyford Road, Newcastle upon Tyne, England NE2 1XG, to receive such assignment and CSDL, as Zeneca's nominee, wishes to acquire the whole right, title and interest in and to the Trademark and the goodwill attached to and/or symbolized by the Trademark;

NOW THEREFORE, in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, AHPC hereby assigns, transfers, and conveys to CSDL all right, title and interest in and to the Trademarks and the applications therefor and registrations thereof, together with the goodwill attached to and/or symbolized by the Trademark, but without the whole of the goodwill of the business concerned in the goods for which the Trademark is registered, along with the right to recover damages and profits and all other remedies for future infringements thereof.

IN WITNESS WHEREOF, AHPC has caused this Assignment to be executed effective this 30th day of June, 1998.
