

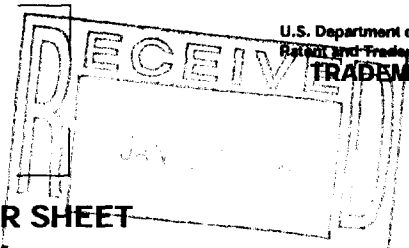

**ASSIGNMENT OF TRADEMARKS AND
