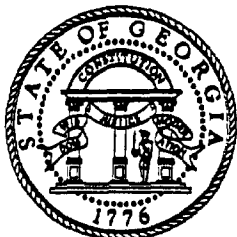

III.


