

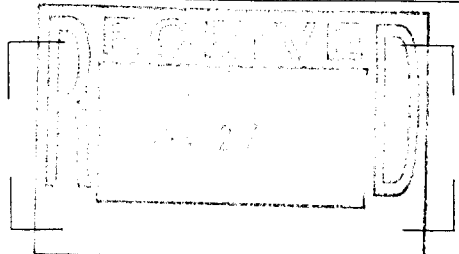

TRADEMARK AND TRADE NAME ASSIGNMENT

THIS TRADEMARK AND TRADE NAME ASSIGNMENT (the "Assignment") is made and entered into as of this 31st day of January, 1995 ("Effective Date"), by and between Makers of KAL, Inc., a California corporation, with its principal office at 6415 DeSoto Avenue, P.O. Box 4023, Woodland Hills, California 91365 ("Assignor"), and Makers of KAL, Inc., a Delaware corporation, with its principal office at 6415 DeSoto Avenue, P.O. Box 4023, Woodland Hills, California 91365 ("Assignee").

Assignor and Assignee are parties to that certain Asset Purchase Agreement dated as of November 16, 1994 (the "Agreement"), pursuant to which Assignor has agreed to sell and Assignee has agreed to purchase the assets, properties and rights pertaining to the Business (as defined in the Agreement).

Assignor is the sole and exclusive owner of the entire right, title and interest in, to and under: (i) the trademarks and the United States trademark registrations on Schedule A and the unregistered trademarks and applications therefor identified on Schedule B; (ii) the foreign trademarks and the foreign trademark registrations and the unregistered foreign trademarks and the applications therefor identified on Schedule C and all unregistered trademarks identified on Schedule D (the foregoing items (i) and (ii) collectively, the "Marks"); (iii) the trade names identified on Schedule E (the "Trade Names"); and (iv) the goodwill of the business associated with the Marks and the Trade Names.

Assignee wishes to acquire and Assignor wishes to assign all right, title and interest in and to the Marks and the Trade Names, together with the goodwill of the business with which the Marks and the Trade Names are used.

THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby sell, assign, transfer and set over to Assignee the entire right, title and interest in and to the Marks and the Trade Names together with the goodwill of the business with which the Marks and the Trade Names are used, and all registrations and applications therefor, in the United States and for all foreign countries, including any renewals and extensions of the registrations that are or may be secured under the laws of the United States and all foreign countries, now or hereafter in effect, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by the Assignor if this Assignment and sale had not been made; together with all income, royalties or payments due or payable as of the Effective Date or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Marks and the Trade Names, with the right to sue for, and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.

Assignor requests the Commissioner of Patents and Trademarks to record Assignee as the assignee and owner thereof.
