ASSIGNMENT OF TRADEMARKS

WHEREAS, ANTHONY'S MANUFACTURING COMPANY, INC., a California corporation having an address of 12812 Arroyo Street, San Fernando, California 91342 (hereinafter "*Assignor*") or its predecessor(s) in interest have adopted and used, and Assignor is currently using, certain trademarks some of which have been registered, or for some of which applications for registration have been filed, in the applicable government offices, as listed on Schedule "A" attached hereto, for use in connection with the goods/services indicated in said registrations or applications therefor or for which the marks are currently being used (collectively, the "*Marks*");

WHEREAS, Assignor has intended to use one or more trademarks in commerce and has filed one or more intent-to-use applications, or intends to file one or more intent-to use applications indicating that intention, but has not yet filed allegations of use under sections 1(c) or 1 (d) of The Trademark Act, which marks and applications are also listed on Schedule "A";

WHEREAS, Assignor is assigning the mark or marks it intends to use, and is assigning the mark or marks in the intent-to-use applications, as part of the entire business as required by 15 U.S.C. 1060;

WHEREAS, NEW ANTHONY, INC., a Delaware corporation having an address of 12812 Arroyo Street, San Fernando, California 91342 (hereinafter "*Assignee*") is desirous of acquiring all right, title and interest in and to said Marks; and

WHEREAS, pursuant to that certain Asset Purchase Agreement dated December 1, 1998, by and between Assignor and Assignee, (the "*Asset Purchase Agreement*"), Assignor has agreed to transfer to Assignee all right, title and interest of Assignor in and to said Marks.

NOW, THEREFORE, in consideration of the foregoing premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby sell, assign, transfer and convey to Assignee all of Assignor's right, title and interest in and to, and to the above-identified Marks, together with the goodwill of the business symbolized by the Marks, all registrations thereof and applications therefor, together with any and all claims for damages or injunction by reason of past infringement of said Marks, with right to sue for and collect the same for its own use and enjoyment, and for the use and enjoyment of its successors, assigns and other legal representatives.

Assignor hereby consents to and requests recordation of this transfer and further authorizes and requests that all official documents and communications relating to said Marks or the registration(s) and/or application(s) therefor issue and deliver to Assignee.

Assignor hereby agrees at Assignee's request to execute in Assignee's favor any and all additional papers which may be necessary for the transfer, by complete assignment, of all Assignor's proprietary rights in and to the above-identified Marks and all registrations thereof or applications therefor, including, without limitation, separate recordable assignments on a country-by-country basis in order to meet government requirements and to facilitate perfection of Assignee's rights in each country.

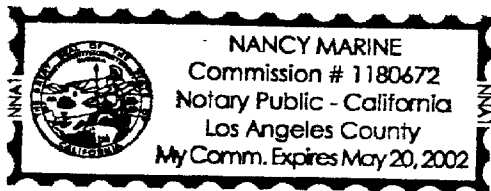
