**AMENDMENT TO ARTICLES OF INCORPORATION OF  
TPR, LIMITED**

The undersigned corporation acting under the Minnesota Business Corporation Act does hereby adopt the following amendment to the Articles of Incorporation for such corporation:

**ARTICLE I**

The name of the corporation is TPR, Limited.
