WHEREAS, Silicon Graphics, Inc., a Delaware corporation having a principal place of business at 2011 N. Shoreline Blvd., Mountain View, CA 94039-7311 ("SGI"), as of August 6, 1998 was the owner of all the issued and outstanding stock of Paragraph International, Inc., ("PII");

WHEREAS, until August 6, 1998, PII was the owner of certain trademarks and service marks, and certain applications and registrations relating thereto, as listed on Schedule A attached hereto and incorporated herein by reference (the "Marks");

NOW THEREFORE, in consideration of the sum of One Dollar (\$1.00) and certain other good and valuable consideration paid to SGI, the receipt and sufficiency of which is hereby acknowledged, subject to the terms of the Agreements, SGI hereby remises, releases and quitclaims to ASSIGNEE any and all of SGI's right, title and interest in and to the Marks listed on Schedule A, including all foreign rights in connection therewith, the goodwill of the business in connection with which the Marks are used, the portion of the existing and ongoing business to which the Marks pertain as required by 15 USC §1060, and the right to sue and recover damages and profits for past infringement.



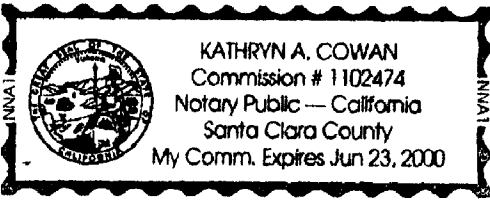
