**TRADEMARK AND SERVICE MARK ASSIGNMENT
(WORLDPLUS INTERNATIONAL INC. to AT&T CORP.)**

THIS TRADEMARK AND SERVICE MARK ASSIGNMENT, effective as of January 1, 1999, is made to AT&T Corp., a New York corporation duly organized and existing under the laws of the State of New York, having an office at 32 Avenue of the Americas, New York, New York 10013-2412, United States of America (hereinafter referred to as the "Assignee") from Worldplus International Inc., a corporation duly organized and existing under the laws of the Delaware, having an office at 295 North Maple Avenue, Basking Ridge, NJ 07920, and a wholly-owned subsidiary of Assignee (hereinafter referred to as "the Assignor").

WHEREAS, the Assignor has registered or applied to register in certain countries throughout the world certain trademarks and service marks set forth in Appendix 1 annexed hereto, including without limitation, the registrations and applications set forth in Appendix 1 (hereinafter referred to as the "Assigned Marks"); and

WHEREAS, the Assignor wishes to transfer and assign to the Assignee, and the Assignee wishes to acquire from the Assignor, all of the Assignor's rights, title and interest in and to the Assigned Marks and all of the goodwill of the business associated therewith, as well as all registrations and applications and other rights, including any common law rights, the Assignor may have throughout the world with respect to such Assigned Marks. Assignee is a successor to the business of Assignor with respect to the use of the Assigned Marks.

Section 1

Effective January 1, 1999, and for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, the Assignor does hereby assign to the Assignee all of its proprietary rights and applications for proprietary rights, title and interest in and to the Assigned Marks, including without limitation, the registrations and applications set forth in Appendix 1, any common law rights in the Assigned Marks, the goodwill of the business relating to the Assigned Marks, and the right to sue for past infringement of the Assigned Marks. Assignee is a successor to the business of Assignor with respect to the use of the Assigned Marks.

Section 2

The Assignor will promptly transfer to or provide to the Assignee copies of all files relating to the registration of, and applications for registration of, the Assigned Marks.
