ASSIGNMENT

WHEREAS, I, **ARNOLD ANGERMAN**, an individual, whose residence address is 229 East 79th Street, New York, New York 10021, am the owner of the trademark **MAGIC VALANCE** and of U.S. Registration No. 2,181,284, issued August 11, 1998 pertaining thereto; and

WHEREAS, **EX-CELL HOME FASHIONS, INC.**, a corporation organized and existing under the laws of the State of New York, and having a place of business at 295 Fifth Avenue, New York, 10016 is desirous of acquiring the entire right, title and interest to the trademark **MAGIC VALANCE** and U.S. Registration No. 2,181,284, issued August 11, 1996, in the United States and worldwide;

NOW, THEREFORE, for the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, **ARNOLD ANGERMAN** does hereby assign unto said **EX-CELL HOME FASHIONS, INC.** its successors and assigns the entire and exclusive right, title and interest in the United States and worldwide in and to the trademark **MAGIC VALANCE** and to the U.S. Registration No. 2 181,284, issued August 11, 1998, thereof, and the goodwill of the business thereto pertaining; the same and the rights of **EX-CELL HOME FASHIONS, INC.** therein to be held and enjoyed for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, to the end of the period of time that said mark is used or the term or terms for which said registration is or may be granted, renewed or re-

issued, whichever occurs later, as fully and entirely as the same would have been held and enjoyed by **ARNOLD ANGERMAN** if this assignment had not been made together with all claims for damages by reason of past infringement of said mark, with the right to sue for and collect the same; and

ARNOLD ANGERMAN agrees to execute any further papers necessary to secure **EX-CELL HOME FASHIONS, INC.** in its full and complete enjoyment of its rights and said mark, such registrations as have or may be granted with respect thereto, and the subject matter thereof; and

ARNOLD ANGERMAN, INC., hereby authorizes and requests the appropriate Trademark Office authorities to issue any and all U.S. trademark registrations and renewals thereof to **EX-CELL HOME FASHIONS, INC.** as assignee of the entire interest therein, and hereby covenants that it has the full right to convey the entire interest herein assigned.
