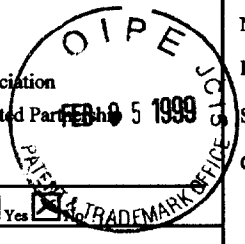

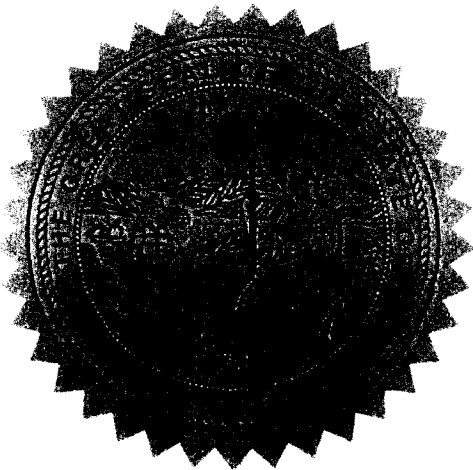

The undersigned corporations, INTERNATIONAL BLUEPRINT, INC., a California corporation ("Blueprint California"), and INTERNATIONAL BLUEPRINT, INC., a Nevada corporation ("Blueprint Nevada"), do hereby certify:

1. Blueprint California is a corporation duly organized and validly existing under the laws of the State of California.
2. Blueprint Nevada is a corporation duly organized and validly existing under the laws of the State of Nevada.
3. Blueprint Nevada will be the surviving corporation.
4. The Articles of Incorporation of Blueprint Nevada as existing prior to the effective date of the merger, shall continue in full force as the Articles of Incorporation of the surviving corporation.

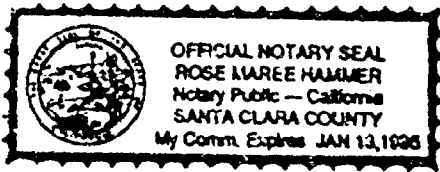

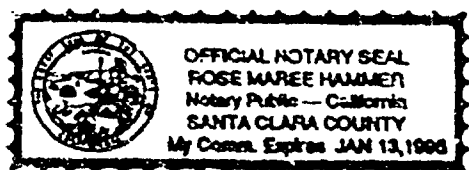

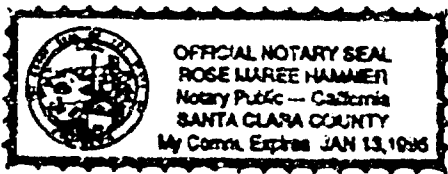
