Pursuant to Section 10-1006, Arizona Revised Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- FIRST: The name of the corporation is Unelko Corporation.
- SECOND: Attached hereto as Exhibit A is the text of each amendment to the Articles of Incorporation of the corporation adopted.
- THIRD: The amendment does not provide for an exchange, reclassification or cancellation of issued shares.
- FOURTH: The amendment was adopted the 14 day of November, 1997.
- FIFTH: The amendment was approved by the shareholders. There is one voting group entitled to vote separately on the amendment. The designation and number of outstanding shares in the voting group entitled to vote separately on the amendment, the number of votes entitled to be cast by the voting group, the number of votes of the voting group represented at the meeting at which the amendment was adopted and the votes cast for and against the amendment were as follows:

The voting group consisting of 418 outstanding shares of voting common stock is entitled to 418 votes. The sole shareholders approved the amendment by written consent. The voting group cast 418 votes for and 0 votes against approval of the amendment. The number of votes cast for approval of the amendment was sufficient for approval by the voting group.
