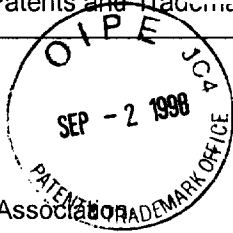

TRADEMARK RELEASE






