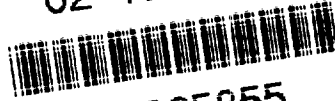

DEED OF ASSIGNMENT




