**RELEASE OF SECURITY INTEREST  
SERVICE MARK AND CORRESPONDING  
REGISTRATION**

THIS RELEASE is entered into this 12<sup>th</sup> day of January, 1999.

**WITNESSETH:**

WHEREAS, Roy H. Park Broadcasting of the Lake Country, Inc., a Minnesota corporation, having a principal place of business at 11320 Valley View Road, Eden Prairie, Minnesota 55343 (hereinafter referred to as "Borrower"), and Teachers' Retirement System of Alabama, an instrumentality of the State of Alabama established as a public corporation having a principal place of business at 135 South Union Street, Montgomery, Alabama 36104-0001 (hereinafter referred to as "Agent"), entered into a "SECURITY AGREEMENT" dated May 11, 1995, which was recorded in the United States Patent and Trademark Office on May 22, 1995, Trademark Reel 1364, Frame 0001, a copy of which is attached hereto as Exhibit A;

WHEREAS, pursuant to the aforesaid SECURITY AGREEMENT, Borrower granted a security interest to the Agent in certain intellectual property owned by Borrower, including, inter alia, the service mark listed in the Schedule 1 to the SECURITY AGREEMENT, and to "any all presently existing and hereafter arising trademarks, trade names, service marks, trademark or service mark registrations, and applications, including, the foregoing listed on Schedule 1 attached hereto";

WHEREAS, Borrower and Agent acknowledge and agree that the obligations and undertakings of the Borrower to the Agent that were secured by the SECURITY INTEREST granted by the Borrower to the Agent have now been performed and satisfied in all respects; and


WHEREAS, Borrower and Agent accordingly desire to confirm and record a RELEASE by the Agent of its said security interest, together with a RELEASE of any and all other rights,

title and interest the Agent may have held or presently holds as a result of the SECURITY AGREEMENT, in and to the service mark and related intellectual property rights identified in the SECURITY AGREEMENT.

NOW, THEREFORE, the Agent hereby and forever releases any and all of the security interest, rights, title and interest, in and to the service mark and any and all other related intellectual property listed or otherwise identified in the SECURITY AGREEMENT which are attached hereto as Schedule 1 and is incorporated herein by reference, which was duly recorded in the United States Patent and Trademark Office as referenced above. Further, Borrower and Agent agree and confirm that this RELEASE OF SECURITY INTEREST will be duly recorded in the United States Patent and Trademark Office, and will be indexed against any and all of the referenced service mark and related intellectual property rights owned by Borrower and/or its assignees and successors in interest.
