WHEREAS, Interpretive Imaging, LLC, a Colorado corporation, ("Assignor"), is the owner of the common law trademarks and pending trademark applications in the form more fully described on **Exhibit A** attached hereto (the "Property");

Assignor agrees, for no additional consideration, to execute and deliver any further documents or instruments and to take all further action reasonably requested by Assignee to further evidence and carry out the assignments contemplated by this Assignment.
