



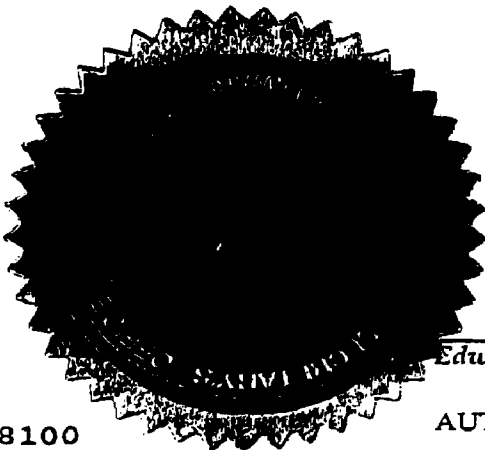

**SECOND:** Article FIRST of the Certificate of Incorporation of the Corporation is hereby amended to read in its entirety as follows:


