- 2. Article I of the corporation's Articles of Incorporation is hereby amended in its entirety to read as follows:

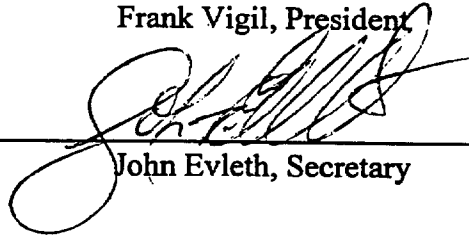
"The name of this corporation is ZapMe! Corporation."

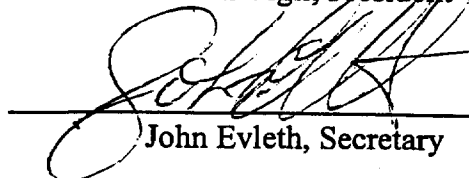

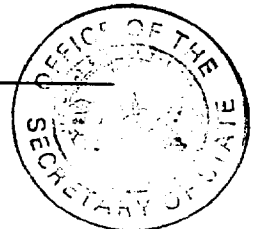
