

## RELEASE

This Release is made and entered into this 23rd day of September, 1998, by The Chase Manhattan Bank, a national banking association and successor of The Chemical Bank, a New York banking corporation (the "Lender"), in favor of The Benjamin Ansehl Company, a Missouri corporation (the "Borrower").
