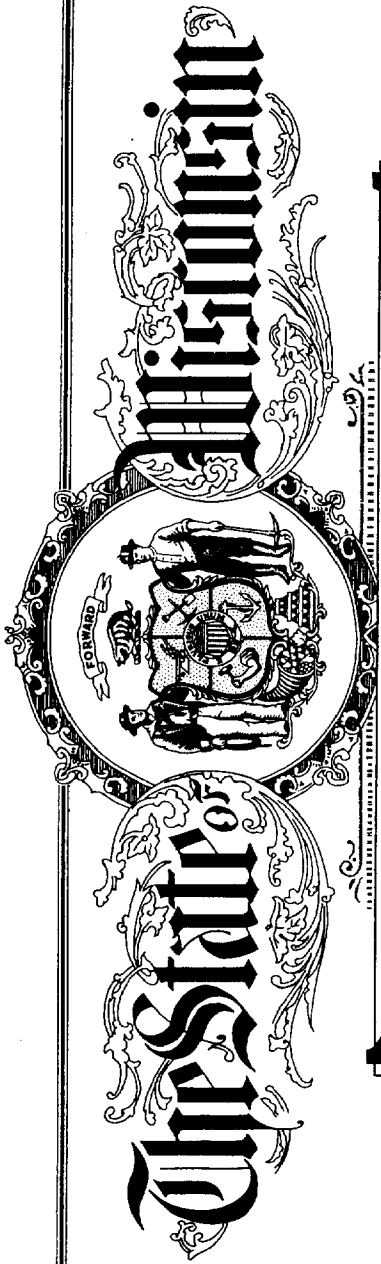

CERTIFICATE RECOGNIZING CONVERSION
FROM A STATE SAVINGS AND LOAN ASSOCIATION TO A STATE SAVINGS BANK

Whereas, The Home Savings and Loan Association has operated as a savings and loan association under chapter 215, Wis. Stats.;

Whereas, chapter 214, Wis. Stats., effective May 7, 1992, establishes the "savings bank" as a new type of state chartered and primarily state regulated financial institution;

Whereas under s.214.685, Wis. Stats., The Home Savings and Loan Association filed an application under the new state law to convert from a state savings and loan association to a state savings bank;

Whereas, The Home Savings and Loan Association has complied with necessary state and federal requirements to convert from a state savings and loan association to a state savings bank;

Now therefore, Harold N. Lee, Jr., Commissioner of Savings and Loan, hereby certifies that, with the filing of its new Articles of Incorporation, The Home Savings and Loan Association has converted from a state savings and loan association to a state savings bank effective after the close of business on June 30, 1993 and is now known as HOME SAVINGS BANK.
