

SECURITY AGREEMENT

WHEREAS, EARTHGRO, INC., a Connecticut corporation with an address of

14111 Scottslawn Road, Marysville, Ohio 43041 (hereinafter referred to as the "Grantor"), owns

the U.S. trademarks, trademark registrations and trademark applications listed on Schedule "A"

annexed hereto; and

WHEREAS, the Grantor has agreed to grant, subject to (i) liens permitted to exist

on such assets pursuant to both the Borrower and Domestic Subsidiary Guarantee and Collateral

Agreement among The Scotts Company, each Domestic Subsidiary Borrower and certain other

Domestic Subsidiaries in favor of The Chase Manhattan Bank, as Administrative Agent (the

"Guarantee and Collateral Agent") and the Credit Agreement (as defined below) and (ii) existing

trademark licenses granted by the Grantor in the ordinary course of rights with respect to such

assets, a security interest in certain assets of the Grantor to secure the payment of all amounts

owing under the Guarantee and Collateral Agreement and the Credit Agreement, dated as of

December 4, 1998 (as amended, supplemented or otherwise modified from time to time, the

"Credit Agreement"), among the Grantor, The Scotts Company, the Domestic Subsidiary

Borrowers, the banks parties thereto (the "Banks"), The Chase Manhattan Bank, as

Administrative Agent (in such capacity, the "Grantee") for the Banks and certain other parties

defined therein.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency

of which is hereby acknowledged, the Grantor does hereby mortgage, pledge and grant to the

security interest in all of the Grantor's right, title and interest in, to and under the following U.S.

trademark applications and trademark registrations, whether presently existing or hereafter arising

or acquired, and which is more fully described in the Guarantee and Collateral Agreement, the

terms and provisions of which are incorporated by reference herein as if fully set forth herein.

Terms defined in both the Credit Agreement and the Guarantee and Collateral Agreement shall

have their defined meanings when used in this Security Agreement:

(i) each U.S. trademark, trademark registration and trademark

application, including, without limitation, each trademark, trademark registration

and trademark application referred to in Schedule A hereto, and all of the goodwill

of the business connected with the use of, and symbolized by, each trademark,

trademark registration and trademark application;

(ii) each trademark license, including, without limitation, each

trademark license listed on Schedule A hereto, and all of the goodwill of the

business connected with the use of, and symbolized by, each trademark license;

(iii) all products and proceeds of the foregoing, including, without

limitation, any claim by the Grantor against third parties for past, present or future

infringement or dilution of any trademark or trademark registration, including,

without limitation, any of the foregoing referred to in Schedule A, and of any

trademark licensed under any trademark license, including, without limitation, any

TRADEMARK REEL: 1858 FRAME: 0320 trademark license listed on Schedule A, or for injury to the goodwill associated with any trademark, trademark registration or trademark licensed under any trademark license.

This security interest is granted in conjunction with the interest granted in both the Credit

Agreement and the Guarantee and Collateral Agreement, which are incorporated herein by

reference, and of which this Security Agreement is a part.
