WHEREAS, JULIE GRAY, an individual ("Assignor") whose address is P.O. Box 183, Belmont, Vermont 05730 is the owner of the trademark WALLIES and the federal registration no. 2,041,318 , (the "Mark"); and

Assignor agrees to execute such further papers and do such other acts as may be necessary and proper to vest full title in and to All Marks in the Assignee or which may be necessary to obtain, renew, issue or enforce All Marks.
