TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of January 28, 1999, by **FIRST UNION NATIONAL BANK.**, as agent for the lenders (the "Agent").

WHEREAS, pursuant to the terms of a Security Agreement dated as of January 29, 1998 (as amended, modified, extended or restated from time to time) by and among Galey & Lord Industries, Inc. This Termination and Release may be executed in any number of counterparts which shall together constitute one and the same agreement.


