INTELLECTUAL PROPERTY ASSIGNMENT II

This Intellectual Property Assignment (the "Assignment") executed on this 10th day of June, 1998, with an effective date of June 1, 1998 (the "Effective Date"), is by and between GenCorp Inc., an Ohio corporation (the "Assignor") and GenCorp Services, Inc., an Ohio corporation (the "Assignee").

WITNESSETH:

WHEREAS, the Assignor owns certain United States trademarks, service marks and trade names (including registrations thereof), used in connection with Assignor's United States operations of its Building & Decorative Products, Specialty Polymers and Penn Racquet Sports Business Units ("United States Intellectual Property") and is desirous of assigning its entire right, title and interest in and to this United States Intellectual Property to Assignee;

WHEREAS, the Assignee is desirous of acquiring assignor's entire right, title and interest in and to the United States Intellectual Property.

NOW THEREFORE, in consideration of the promises and obligations set forth herein and other good and valuable consideration, the Assignor and Assignee hereby agree as follows:

ARTICLE I ASSIGNMENT

For value received, and subject to the terms and conditions of all existing legally binding agreements, licenses, and/or encumbrances, Assignor hereby assigns and transfers to Assignee, its successors and assigns, the entire right, title, and interest Assignor has in and to:

a) the United States Trademarks and Service Marks (including registrations thereof) listed on Exhibit B, which is attached hereto and incorporated herein in full by reference, together with the goodwill of the business symbolized by said trademarks and service marks, the right to amend and renew, and the right to sue for past infringement;

b) the trade names (including registrations thereof) listed in Exhibit C which is attached hereto and incorporated herein in full by reference, together with the goodwill of the business symbolized by the trade names, the right to amend and renew, and the right to sue for past infringement; and

c) any and all other United States trademarks, service marks and trade names (including registrations thereof) together with the goodwill symbolized by said marks now used in connection with Assignor's United States operations of its Building &

Decorative Products, Specialty Polymers and Penn Racquet Sports Business Units not specifically listed above, whether or not currently used in the conduct of business, provided that a unilateral transfer thereof is not precluded by the terms and conditions of an existing legally binding agreement and further provided that the transfer is subject to all existing licenses and/or other encumbrances.

ARTICLE II

It is expressly agreed that this Assignment is not merely of the rights to the tangible embodiment of information such as registrations on which said United States Intellectual Property is recorded, but it is an assignment and transfer of any and all right, title and interest Assignor has in the United States Intellectual Property including any and all rights to use, and to prosecute past, current, and future infringements and/or misuses of this United States Intellectual Property.

ARTICLE III

Assignor represents and warrants that the United States Intellectual Property assigned and transferred pursuant to this Assignment is owned by Assignor, that Assignor has a right to transfer and assign this United States Intellectual Property, and that any and all registered trademarks, service marks and trade names are in force. If the transfer or assignment of any item(s) of the United States Intellectual Property violates the terms of any existing legally binding agreement, said item(s) shall be removed from this Assignment and the validity, legality, and enforceability of the remaining provisions of this Assignment and of the property assigned shall not be affected or impaired thereby.


ARTICLE IV

Assignor agrees that, on request and at Assignee's expense, it will communicate to Assignee or its representatives or nominees, any facts known to Assignor respecting the United States Intellectual Property, and will testify in any legal proceeding, execute documents, and otherwise do everything possible to aid Assignee, or its successors, assigns, and nominees, to obtain and enforce protection for the United States Intellectual Property.

IN WITNESS WHEREOF, the parties have caused this Assignment to be executed on their behalf by their duly authorized representatives as of the Effective Date.
