RELEASE AND REASSIGNMENT OF TRADEMARKS

THIS RELEASE AND REASSIGNMENT dated as of January \_\_, 1999 by Bank of America National Trust and Savings Association, as Agent (as hereinafter described);

W I T N E S S E T H:

WHEREAS, Bank of America National Trust and Savings Association, a national banking association, as agent for itself and the Lenders as defined in the Assignment hereinafter referred to (in such capacity, the "Agent") and Sunbelt Manufacturing, LLC, a Delaware limited liability company ("Sunbelt") are parties to a certain Collateral Trademark Security Agreement dated as of September 12, 1997 which was recorded in the United States Patent and Trademark Office on February 26, 1998 at Reel 1691 Frame 0947, inclusively (the "Assignment"), pursuant to which Sunbelt granted a security interest in and collateral assignment of certain trademarks listed on Attachment I hereto and certain other property (collectively the "Trademarks"), among other things, as security for Sunbelt's "Obligations" (as defined in the Assignment) to the Agent and Lenders owing under that certain Credit Agreement dated as of September 12, 1997 among Sunbelt, the Lenders, Bancamerica Securities, Inc. and the Agent; and

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:



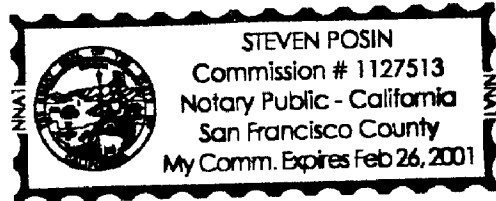
