

1. They are the duly elected and acting President and Secretary, respectively, of Silicon Valley Internet Partners, a California corporation.
2. Article I of the Articles of Incorporation of this corporation is amended to read as follows:

"ARTICLE I

The name of this corporation is Viant Corporation."


3. The foregoing amendment to the Articles of Incorporation has been duly approved by the majority of the Board of Directors in accordance with Section 901 of the California Corporations Code.



The foregoing amendment to the Articles of Incorporation of this corporation has been duly approved by the shareholders of this corporation in accordance with Sections 902 and 903 of the California Corporations Code. The total number of outstanding shares of the Company entitled to vote on the foregoing amendments to the Articles of Incorporation of this corporation is three million five hundred fifty-six thousand two hundred fifty-eight (3,556,258) shares of Common Stock; five million seven hundred forty-six thousand eight hundred seventy-four (5,746,874) shares of Series A Preferred Stock; one million four hundred ninety-nine thousand nine hundred twenty-five (1,499,925) shares of Series B Preferred Stock, and two million seven hundred fifty-nine thousand six hundred twenty-five (2,759,625) shares of Series C Preferred Stock. The number of shares voting in favor of the foregoing amendment to the Articles of Incorporation equaled or exceeded the vote required.
