



Said Trademark was granted to Sirrom Investments, Inc. by Clearidge, Inc., 2710 Landers Avenue, Nashville, Tennessee 37211, which security interest is dated April 1, 1998, and which was recorded in the U.S. Patent and Trademark Office on April 9, 1998, at Reel 1716, Frame 0100, to which reference may be had.

Due to the previous Assignment of its entire right, title and interest in and to the Trademark by Clearidge to CoreStates Bank, N.A., now known as First Union National Bank, a national banking corporation, as successor by merger, as filed at Reel 1732, Frame 0185 in the U.S. Patent and Trademark Office on February 17, 1998, Clearidge was not the current owner of record in the U.S. Patent and Trademark Office at the time of the filing of Sirrom's Security Agreement, causing there to be a defect in the chain of title in the Trademark's record at the U.S. Patent and Trademark Office.
