WHEREAS, Dexus Corporation, a Maryland corporation having offices located at 326 First Street, Yacht Haven, Suite 11, Annapolis, Maryland 21403 (ASSIGNOR"), owns all right, title and interest in and to the trademark WIPEITS and U.S. Reg. No. 2,081,862 therefor, and the goodwill of the business symbolized by the aforesaid trademark; and

WHEREAS, Global Material Technologies, Incorporated (formerly known as American Steel Wool Mfg. Co., Inc.), a New York corporation, having offices located at 1540 E. Dundee Road, Suite 210, Palatine, Illinois 60067, (ASSIGNEE"), desires to acquire all of ASSIGNOR's right, title and interest to the aforesaid trademark and registration therefor, and the goodwill of the business symbolized by said trademark.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, said ASSIGNOR has sold, transferred, and assigned and by these presents does hereby sell, transfer, and assign to ASSIGNEE, its successors, assigns and legal representatives, all of the right, title, and interest in and to said trademark WIPEITS and U.S. Reg. No. 2,081,862 therefor, and the goodwill of the business symbolized by said trademark, together with all rights under any applicable international treaties and agreements, the same to be held and enjoyed by ASSIGNEE for its own use and benefit and the use and benefit of its successors, assigns and legal representatives, as fully and entirely as the same would have been held and enjoyed by ASSIGNOR, together with all income, royalties, damages or payments resulting from or attributable to activity or conduct after the effective date of this Assignment, including without limitation, all worldwide rights to the aforesaid trademark, registration therefor, the goodwill of the business symbolized by said trademark and the right to sue and collect for all future, present and past infringements thereof, including infringements which may have occurred prior to the execution of this Assignment.

ASSIGNOR agrees: (a) to execute (i) all necessary papers throughout the world to be used in connection with the aforesaid trademark and registration as ASSIGNEE may deem necessary or expedient, (ii) all papers in connection with any interference, legal or other proceedings throughout the world to maintain, protect or enforce, or otherwise relating to, the aforesaid trademark and registration, and (iii) all papers and documents which may be necessary throughout the world in connection with the preparation and filing of any foreign applications for the aforesaid trademark and registration; (b) to cooperate with ASSIGNEE at ASSIGNEE's expense in every way reasonably possible in obtaining evidence and going forward in any such proceedings throughout the world; and (c) at ASSIGNEE's expense to perform all other affirmative acts which in ASSIGNEE's reasonable discretion may be necessary or desirable throughout the world to maintain, protect or enforce the aforesaid trademark and registration. These obligations of assistance by

Assignor shall continue for so long as Assignee may require such assistance from Assignor.

ASSIGNOR hereby grants to the law firm of LAFF, WHITESEL, CONTE & SARET, LTD., authority and power to insert on this instrument any further information which may be necessary or desirable for identifying the aforesaid trademark or trademark registration for purposes of recordation in the United States Patent and Trademark Office or in any foreign country.


