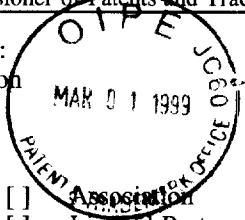

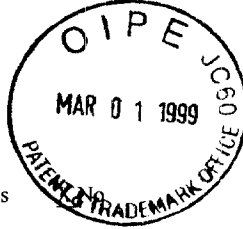



Wayne (Silby), residing at 1715 18th Street, N.W., Washington, D.C., a citizen of the United States of America, (hereafter collectively referred to as "Assignors"), have invented certain new and useful improvements in "**CENTRIFUGAL COMMUNICATION AND COLLABORATION METHOD**", for which an application for United States Letters Patent was filed on March 13, 1998, serial number 09/041,599, with the same title, and

WHEREAS, **GroupServe, Inc.**, located at 1918 18th Street, N.W., B2, Washington, D.C. 20009, (hereafter referred to as the "Assignee"), is desirous of acquiring the entire right, title and interest in and to the said invention, and in and to the said application, and any Letters Patent that may issue thereon;

NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN, be it known that for and in consideration of One Dollar (\$1.00), and other valuable and legally sufficient consideration, the receipt of which is hereby acknowledged, the Assignors have sold, assigned, and transferred, and do hereby sell, assign and transfer to the Assignee, its successors and assigns, their entire right, title and interest for the United States in and to the said invention and in and to the said application and all patents which may be granted therefor, and all divisions, reissues, substitutions, continuations, in whole or in part, re-examinations, and extensions thereof, and all applications claiming priority therefrom; and the Assignors hereby authorize and request the Commissioner of Patents and Trademarks to issue all patents for said invention, or patents resulting therefrom, insofar as their interest is concerned, to the Assignee; to have and to hold for the sole and exclusive use and benefit of the Assignee, its successors and assigns, to the full end of the term or terms for which any and all of said Letters Patent for said invention may issue.

The Assignors also have sold, assigned, and transferred, and do hereby sell, assign and transfer to the Assignee, its successors and assigns, their entire right, title and interest in and to the invention disclosed in said application, in all countries of the world foreign to the United States, including the right to file applications and obtain patents for said invention in its own name in said countries and including all rights of priority in said countries under the terms of any applicable international convention; to have and to hold for the sole and exclusive use and benefit of the Assignee, its successors and assigns, to the full end of the term or terms for which any and all of said Letters Patent for said invention may issue.

The Assignors further agree to execute any and all patent applications, assignments, affidavits, and any other papers in connection therewith necessary to perfect such patent rights, and also agree, at the request of the Assignee, to testify in any legal proceedings, sign all lawful papers, make all lawful oaths, and generally do everything possible to aid said Assignee, its successors and assigns, to obtain, maintain and enforce proper patent protection for said invention in all countries.

The Assignee hereby grants to the Assignors a license of the invention and under any resulting patent, the license being limited to a right to sub-license the invention and/or the patent, royalty-free, to (a) up to three non-profit entities for their own use in connection with their corporate chartered

purposes, and (b) a for-profit entity in which Silby and Achacoso have, collectively, a material interest, defined as each holding at least 5% of the shares.
