**THIS ASSIGNMENT AND RELEASE OF SECURITY INTEREST IN PATENTS,
TRADEMARKS, COPYRIGHTS AND LICENSES, ("Release"), dated as of the 19 day of
August, 1998, is made by Mellon Financial Services Corporation, a Delaware corporation
("Mellon").**

WITNESSETH:

**WHEREAS, Stuart Hall Company, Inc., a Missouri corporation (the "Company")
and Mellon, are parties to a certain Loan and Security Agreement ("Security Agreement") dated
August 29, 1984;**

**WHEREAS, pursuant to that certain Security Agreement the parties entered into a

interest in, and reassigns, transfers and conveys to the Company, any and all right, title and interest
which Mellon has in or to the Patents, Trademarks, Copyrights and Licenses, including without
limitation, the trademarks listed on Attachment I hereto. Mellon agrees that it will execute all such
further documents as may be requested by the Company to carry out the transactions contemplated
hereunder.**
