On January 28, 1985, each share of Series A Preferred Stock was convertible into 1,311.7 shares of Common Stock, each share of Series B Preferred Stock was convertible into 2.14 shares of Common Stock, each share of Series C Convertible Preferred Stock was convertible into 1.05 shares of Common Stock, each share of Series D Convertible Preferred Stock was convertible into 3.117 shares of Common Stock, and each share of Series E Convertible Preferred Stock was convertible into 1.3117 shares of Common Stock.

Each holder of any series of Preferred Stock has a total of 1,000,000 votes and a right of participation in all dividends, together as a single class representing at least one percent of the votes and the interest thereon could be favor of the accompanying notes.
