NEVADA/TIG, INC., a corporation organized under and existing by virtue of the laws of the State of Nevada, does hereby certify that the following resolution was unanimously adopted at a special meeting held by teleconference held on January 22, 1990, by the Board of Directors of the Corporation pursuant to the provisions of the By-Laws of the Corporation:

RESOLVED, that the Board of Directors does hereby declare it advisable and in the best interest of the Corporation and does hereby propose that Article I of the Articles of Incorporation be amended to read in its entirety as follows:

"ARTICLE I

The name of the corporation is INTERFACE GROUP - NEVADA, INC."

The amendment to these Articles was approved by a unanimous vote of the Board of Directors of the corporation and approval by unanimous vote of all the stockholders.

Pursuant to N.R.S. 78.390(1)(c), the Articles are amended upon filing of this Certificate with the Nevada Secretary of State.
