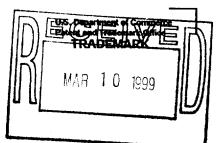

CERTIFICATE OF AMENDMENT TO AMENDED AND RESTATED CERTIFICATE OF INCORPORATION OF SUGAR ACQUISITION CORPORATION

Pursuant to Sections 242 of the Delaware Corporation Law of the State of Delaware, the undersigned, being the President and Chief Executive Officer of Sugar Acquisition Corporation, a Delaware corporation (the "Corporation") does hereby certify the following:

FIRST:

RECORDED: 03/10/1999

The name of the Corporation is Sugar Acquisition Corporation.

SECOND: The Amended and Restated Certificate of Incorporation of the Corporation was filed with the Secretary of State of Delaware on December 23, 1998.

THIRD: The Amended and Restated Certificate of Incorporation of the Corporation is hereby amended to effect a change in <u>Articles One</u> and <u>Article Five</u> thereof, relating to the name and the mailing address of the Corporation.
