## ACKNOWLEDGMENT & RELEASE



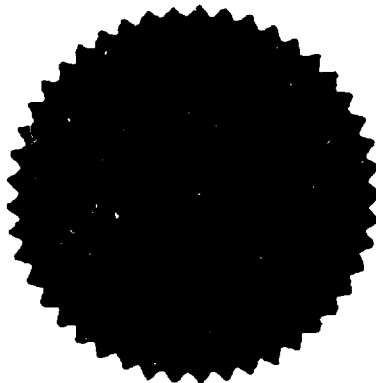
