GENERAL ASSIGNMENT AND BILL OF SALE

THIS GENERAL ASSIGNMENT AND BILL OF SALE (the "Assignment"), being effective as of July 31, 1998, by DYNAPOLIS LLC, a Washington limited liability company ("Seller"), to JANEROS CORPORATION, a Nevada corporation ("Buyer").

For good and valuable consideration, the receipt and sufficiency of which are acknowledged, the parties agree as follows:

1. Seller hereby sells, assigns, grants, transfers, sets over, conveys and delivers to Buyer, its successors and assigns, all of Seller's right, title and interest in and to its assets, including, but not limited to, all Seller's intellectual property, valued at \$130,000.
2. Buyer hereby assumes from Seller, and agrees to pay or otherwise perform or discharge in accordance with its terms, the loan payable to Jane Thilo, M.D. in the amount of \$30,000.
3. Buyer will issue one million (1,000,000) shares of Buyer's Common Stock to Seller. Because Seller is currently in the process of winding up, Seller directs Buyer to issue the shares directly to its members in proportion to their interests in Seller.
