ASSIGNMENT OF TRADEMARK

FOR VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, SIMPSON PAPER COMPANY, a Washington corporation ("Assignor"), hereby makes and executes the following Assignment of Trademark to SIMPSON PASADENA PAPER, a Washington corporation ("Assignee").

WHEREAS, Assignor is the sole and exclusive owner of all right, title and interest in and to the mark Laredo® and the registration thereof in the United States Patent and Trademark Office Reg. No. 1,893,611 (the "Mark"); and

WHEREAS, Assignee is desirous of acquiring the entire right, title and interest in and to the Mark, together with the goodwill of the business appurtenant thereto and symbolized thereby and the right to recover damages and profits for past infringement thereof;

NOW, THEREFORE, the parties agree as follows:

1. Assignor does hereby assign, contribute, transfer, convey and grant to Assignee, its successors and assigns, all right, title and interest in and to the Mark, together with the goodwill of the business appurtenant thereto and symbolized thereby and the right to recover damages and profits for past infringement thereof.

2. Assignor further covenants and agrees that it will at any time upon request communicate to Assignee, its successors and assigns, any facts pertinent to the history, validity or enforceability of the Mark that are known to Assignor and that Assignor will, at Assignee's expense, testify as to the same in any opposition, cancellation or other litigation, when and if requested to do so by Assignee, its successors or assigns.

3. This Assignment of Trademark shall be governed by, construed under, and enforced in accordance with the laws of the State of Texas without reference to the conflict of laws provisions thereof.
