

ASSIGNMENT

Metropolitan Ambulance & First Aid Corp. ("Applicant"), a New York corporation with its principal place of business at 5811 Foster Avenue, Brooklyn, New York 11234, is the owner of the trademark application, based on 15 U.S.C. § 1051(b), which is identified in Exhibit A ("METROCARE").
