

CORRECTIVE DOCUMENT

On September 10, 1997, Calspan Corporation, 4455 Greene Street, Buffalo, New York 14225 ("Calspan"), granted to NBD Bank N.A., One Indiana Square, Indianapolis, Indiana 46266 ("NBD"), a security interest in certain property, including all of Calspan's trademarks. Calspan's trademarks were set forth in Schedule 1(h(iii) to Exhibit I of the Subsidiary Guarantor Security Agreement between Calspan and NBD and included United States Trademark Registration No. 1,283,083 of the mark DIAMOND VISION issued June 26, 1984 ("DIAMOND VISION Registration").

On October 17, 1997, NBD recorded its security interest in the trademarks of Calspan with the United States Patent and Trademark Office. Such security interest was recorded at Reel/Frame 1647/0584 and was indexed against three trademark registrations including the DIAMOND VISION Registration.


Notwithstanding Calspan's representations to NBD regarding Calspan's ownership of the DIAMOND VISION Registration, the records of the United States Patent and Trademark Office indicate that the DIAMOND VISION Registration was issued to Mitsubishi Electric Corporation, 2-3, Marunouchi 2-chome Chiyoda-ku, Tokyo, Japan on June 26, 1984 and has never been assigned to Calspan or any other entity. As a result, the recordation of NBD's security interest in the trademarks of Calspan should not have been indexed against the DIAMOND VISION Registration since Calspan had no interest in such registration.

Since the security interest granted to it by Calspan in the DIAMOND VISION registration never existed because Calspan had no rights in the DIAMOND VISION registration, NBD is filing this Corrective Document to correct the record of title

regarding the DIAMOND VISION Registration. To the extent necessary to effectuate the correction of the record of title regarding the DIAMOND VISION Registration, NBD hereby releases, discharges, quit claims and relinquishes any right, title and interest in the DIAMOND VISION Registration as a result of the security interest in the property of Calspan recorded on October 17, 1997 at Reel/Frame 1647/0584.
