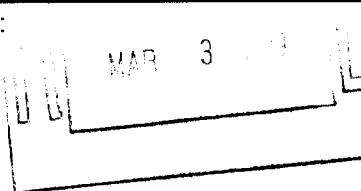

ASSIGNMENT OF TRADEMARKS

Assignor does hereby sell, transfer, convey, assign, and deliver unto Assignee the entire worldwide right, title and interest in and to the Trademarks including all common law rights, connected therein together with the goodwill of the business symbolized by the Trademarks. Assignor agrees to immediately terminate and refrain from any further use of the Trademarks for any purpose and to execute any other documents necessary to effectuate and record this Assignment. Assignor further assigns to Assignee all right to sue for and receive all damages accruing from past infringements of the Trademarks herein assigned.



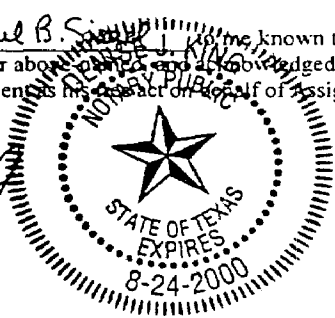
