Federal Armored Express, Inc., a Maryland corporation, having its principal office in Baltimore City, Maryland (hereinafter called the "Corporation") hereby certifies to the State Department of Assessments and Taxation of Maryland that:

FIRST: The Corporation hereby amends its Charter as currently in effect by striking out Paragraph First of the Articles of Incorporation and inserting in lieu thereof the following:

FIRST: The name of the Corporation, which is hereinafter called the "Corporation", is:

DUNBAR ARMORED, INC.


