

Should the Assignor fail to do any of the foregoing, the Assignor hereby appoints Assignee as attorney-in-fact, with full and irrevocable power and authority to execute, register and record all such documents, in the name of and on behalf of the undersigned, as Assignee may deem necessary or proper in the premises to accomplish the same (which appointment is coupled with an interest and is irrevocable).
