PARALLAX GRAPHICS, INC. (the "Corporation"), a corporation
organized and existing under the laws of the State of Delaware, HEREBY CERTIFIES:

FIRST: That the Corporation was incorporated on March 9, 1999 under the name Parallax Graphics, Inc. pursuant to the General Corporation Law of the State of Delaware (the "DGCL").

SECOND: That Parallax Graphics, Inc. ("Old Parallax") was incorporated on November 24, 1982, pursuant to the General Corporation Law of the State of California.

THIRD: That an Agreement and Plan of Merger, dated as of March 10, 1999, between the Corporation and Old Parallax (the "Agreement"), providing for Old Parallax to be merged into and survived by the Corporation (the "Merger"), has been approved, adopted, certified, executed and acknowledged by each of the Corporation and Old Parallax in accordance with Section 252 of the DGCL.

FOURTH: That the Corporation shall be the surviving corporation (the "Surviving Corporation") of the Merger. The Certificate of Incorporation of the Surviving Corporation will be the Certificate of Incorporation of the Surviving Corporation.

FIFTH: That the By-Laws of the Corporation shall be the By-Laws of the Surviving Corporation.

SIXTH: That the directors and officers of the Corporation shall be the directors and officers, respectively, of the Surviving Corporation, each to hold such

office until his or her successor shall be elected or appointed and qualified or until his or her earlier death, resignation or removal.

SEVENTH: That the Merger has been approved by the written consent Dynatech LLC, a Delaware limited liability company ("Dynatech"), the holder of all the issued and outstanding shares of common stock of Old Parallax and the Corporation, in accordance with Section 228(a) of the DGCL and Section 603(a) of the California General Corporation Law.

EIGHTH: That the executed Agreement is on file at an office of Dynatech at 20410 Observation Drive, Germantown, MD 20876. A copy will be furnished, on request and without cost, to any shareholder of the Corporation.

NINTH: That the number of shares of stock of all classes which Old Parallax has authority to issue is two million (2,000,000) shares, each with no par value.

TENTH: Notwithstanding anything to the contrary, the Merger may be terminated and abandoned by the Board of Directors of the Corporation or Old Parallax at any time prior to the filing of this Certificate.
