**TERMINATION OF SECURITY INTEREST AND RELEASE OF COLLATERAL**

THIS TERMINATION OF SECURITY INTEREST AND RELEASE OF COLLATERAL is made effective as of March 10, 1999 (the "Effective Date") by Union Planters Bank National Association ("the Bank").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the the Bank hereby (1) releases, discharges and disclaims, any lien, security interest, pledge and/or assignment created in its favor which burdens the Eames Trademark, and (2) grants, assigns and conveys, without covenant or warranty, express or implied, all of the the Bank's right, title and interest in the Eames Trademark to Lucia Eames, a U.S. citizen d/b/a Eames Office.


