NOTICE AND AGREEMENT REGARDING SECURITY INTEREST IN PATENTS, TRADEMARK REGISTRATIONS, TRADEMARK APPLICATIONS, AND COPYRIGHT REGISTRATIONS

THIS NOTICE AND AGREEMENT REGARDING SECURITY INTEREST IN PATENTS, TRADEMARK REGISTRATIONS, TRADEMARK APPLICATIONS, AND COPYRIGHT REGISTRATIONS (the "Agreement") is made effective as of February 25, 1999, among ORECK CORPORATION, a Delaware corporation (referred to below as "Borrower"), ORECK HOLDINGS, LLC, a Delaware limited liability company (referred to below as "Grantor"), and BANK ONE, Louisiana, N.A. (referred to below as "Lender").

RECITALS

- A. Borrower, Grantor and Lender have entered into that certain Amended and Restated Commercial Security Agreement and related documents dated February 25, 1999, whereby Lender has agreed to make certain loans to Borrower under certain terms and conditions. (Hereinafter the Amended and Restated Commercial Security Agreement and all related documents evidencing the loans and security agreements between Borrower, Grantor and Lender are referred to as the "Loan Documents".)
- B. Pursuant to the terms of the Loan Documents, Grantor has agreed to grant Lender a continuing security interest in the Collateral including the Intellectual Property Rights and Claims as defined below.
- C. Lender desires to have a continuing security interest in the Collateral confirmed by recording this document in the United States Patent and Trademark Office ("PTO") and the United States Copyright Office ("Copyright Office").
- NOW, THEREFORE, with the foregoing Recitals deemed incorporated into and made a part of this Agreement by reference, and in consideration of the mutual promises and obligations set forth below, the parties, intending to be legally bound, agree as follows:
- 1. **SECURITY INTEREST.** In consideration of the covenants and agreements contained in the Loan Documents, and for other good, valuable and sufficient consideration, the receipt of which is hereby acknowledged by Borrower and Grantor, and to secure the obligations owing under the Loan Documents, Grantor grants to Lender a continuing security interest in:
- Letters Patent and United States Trademark Registrations, including the subject marks and the associated goodwill, described in <u>Exhibit A</u> attached hereto, and any future United States patents and United States trademark registrations (the "Patents and Trademark Registrations"); (b) the applications for United States Trademark Registration, including the subject marks and the associated goodwill, as set forth on Exhibit A, and any future United

States Trademark Applications (the "Trademark Applications"); (c) any reissue, extension, or renewal of the Patents and Trademark Registrations, or any division of the Trademark Applications (such reissues, extensions, renewals, and divisions are referred to collectively as the "Further Rights"); (d) all copyrights registered with the Copyright Office described in Exhibit A, and any future registrations with the Copyright Office ("Copyrights"); (e) all future royalties or other fees paid or payment or payments made or to be made to Grantor or Borrower in respect to the Patents and Trademark Registrations, Trademark Applications, Copyrights, and Further Rights (the "Royalties"); and (f) proceeds of any and all of the foregoing (the Patents and Trademark Registrations, Trademark Applications, Further Rights, Copyrights and Royalties, which are referred to collectively as the "Intellectual Property Rights").

1.2. All rights, interests, claims and demands that Grantor or Borrower have or may have in existing and future profits and damages for past and future infringements of the Intellectual Property Rights (the "Claims") (the Intellectual Property Rights and Claims are referred to collectively as the "Collateral").

2. **GRANTOR'S WARRANTY.** Grantor warrants and represents that:

- 2.1. Grantor is the true and lawful exclusive owner of the Intellectual Property Rights set forth on Exhibit A, including all rights and interests granted by this Agreement.
- 2.2. To the best of Grantor's knowledge, the Collateral is valid and enforceable.
- 2.3. Grantor has full power and authority to execute and deliver this Agreement.
- 2.4. Grantor has no notice of any suits or actions commenced or threatened against it, or notice of claims asserted or threatened against it, with reference to the Intellectual Property Rights and the interests granted by this Agreement, other than those previously disclosed to Lender.
- 2.5. Other than the non-exclusive licenses granted to subsidiaries and affiliates of Grantor in the ordinary course of business, the Intellectual Property Rights and all interests granted in the Collateral are so granted free from all liens, charges, claims, options, licenses, pledges and encumbrances of every kind and character.
- 3. **AFFIRMATIVE COVENANTS.** Borrower and Grantor further covenant that, until all of the above-described obligations have been satisfied in full, Borrower and Grantor will:
- 3.1 Not enter into any agreement(s), including, without limitation, license agreements, which are inconsistent with Borrower's and Grantor's undertakings and

covenants under the Loan Documents or this Agreement or which restrict or impair Lender's right to realize upon the security interest granted under this Agreement.

- 3.2. Take reasonable steps to protect, maintain and enforce the Patents, Trademark Registrations, Trademark Applications, and Copyrights, and to maintain the quality of the goods and services associated with the trademarks so that the goods are of good workmanship and quality and so that the services are of good quality and rendered in a good workmanlike manner and be at or above the level of quality as of the date of this Agreement.
- 4. **RESTRICTIONS ON SALE OR FURTHER ENCUMBRANCE.** Grantor agrees not to sell, assign or further encumber Grantor's rights and interests in the Collateral, except in the ordinary course of business, without the prior written consent of Lender.
- LENDER'S RIGHTS ON DEFAULT. If Borrower or Grantor default 5. under the Loan Documents, Lender, as the holder of a security interest under the Louisiana Uniform Commercial Code as now or hereafter in effect, may take such action as is permitted by law or in equity, in Lender's sole discretion, to foreclose on or otherwise realize on the Collateral covered by this Agreement. For those purposes, and only in the event that Grantor or Borrower default under the Loan Documents, Grantor hereby conditionally authorizes and empowers Lender to make, constitute and appoint any officer or agent of Lender as Lender may select in Lender's sole discretion, as Grantor's true and lawful attorney-in-fact with the conditional power to endorse Grantor's name on and/or file of record, all assignments, applications, documents, papers and instruments, whether signed by Grantor or by Lender on Grantor's behalf, necessary for Lender or its transferees, successors or assigns, to obtain title to and the right to use the Collateral together with the associated goodwill, or to grant or issue any exclusive or nonexclusive license under the Collateral to any other person or to assign, pledge, convey or otherwise transfer title in or dispose of all or any part of the Collateral and associated goodwill to any other person. Grantor hereby ratifies all that the attorney-in-fact shall lawfully do or cause to be done by virtue of this Agreement. This power of attorney shall be irrevocable during the term of the Loan Documents.
- 6. **REMEDIES.** Upon the occurrence of any Event of Default as defined in the Loan Documents and the lapse of any applicable cure period, and at all times thereafter, Lender shall have the rights and remedies of a secured party under the UCC in addition to the rights and remedies provided elsewhere within the Security Agreement or in any other writing executed by Grantor. Lender will give Grantor reasonable notice of the time and place of any public sale of the Collateral or of the time after which any private sale or other intended disposition thereof is to be made. The requirement of reasonable notice shall be met if such notice is mailed to the last known address of Grantor at least ten (10) days before the time of the public sale or the time after which any private sale or other intended disposition thereof is to be made. At any such public or private sale, Lender may purchase the Collateral. After deduction for Lender's expenses related to any such public or private sale, the residue of any such proceeds of sale shall be applied in satisfaction of the Grantor's obligations in such order of preference as Lender may determine. Any excess, to the extent permitted by law, shall be paid to Grantor. To

the extent that a deficiency remains after any such public or private sale, Lender may obtain a judgment against Grantor for any such deficiency. Lender shall have the right, but not the obligation, to take all such actions and to do all such things as Lender deems reasonably necessary to protect and preserve the Collateral and Lender's rights hereunder.

- 7. FILING OF DOCUMENTS WITH PTO. Grantor shall, at Grantor's own expense and to the extent Lender deems it necessary, diligently file and prosecute all Trademark Applications relating to the Collateral in the PTO, and, except in the ordinary course of business, shall pay or cause to be paid in their customary fashion all fees and disbursements in connection therewith, and shall not abandon, except in the ordinary course of business, any such Collateral before the exhaustion of all administrative and judicial remedies without the prior written consent of Lender.
- 8. FEES, COSTS AND EXPENSES. Any and all fees, costs and expenses, including reasonable attorneys' fees and expenses, incurred by Lender in connection with the preparation, modification, enforcement or termination of this Agreement and all other documents relating to this Agreement and to the consummation of the transactions contemplated by this Agreement, the filing and recording of any documents (including all taxes in connection therewith) in public offices, any taxes, counsel fees, maintenance fees, encumbrances or costs otherwise incurred in defending or prosecuting any actions or proceedings arising out of or related to the Collateral, shall be paid by Grantor on demand by Lender and, until paid, shall be added to the obligations described in the Loan Documents.
- 9. SUIT TO ENFORCE COLLATERAL. Grantor shall promptly provide Lender with prior written notice of any suit to enforce the Collateral. Lender may, at Lender's option, be joined as a nominal party to the suit if Lender shall be satisfied that joinder is necessary and that Lender is not thereby incurring any risk of liability by that joinder. Grantor shall promptly, on demand, reimburse and indemnify, defend and hold Lender harmless from and against all damages, costs and expenses, including reasonable attorneys' fees, incurred by Lender pursuant to this Section 9 and all other actions and conduct of Grantor with respect to the Intellectual Property Rights during the term of this Agreement.
- 10. **MODIFICATION; WAIVER.** No modification or waiver of any provisions set forth in this Agreement shall be effective unless the same shall be in writing and signed by the party against whom enforcement is being sought.
- Grantor fails to comply with any of Grantor's undertakings and covenants under the Loan Documents or this Agreement, Lender may, at Lender's sole option, do so in Lender's name, but at Grantor's expense. Grantor agrees to reimburse Lender in full for all expenses, including reasonable attorneys' fees, incurred by Lender in protecting, defending, enforcing and maintaining the Collateral.
- 12. **TERMINATION OF LENDER'S INTEREST IN COLLATERAL.** On full and unconditional satisfaction of all of Borrower's obligations to Lender under the Loan

Documents, Lender shall execute and deliver to Borrower and Grantor all documents reasonably necessary to terminate Lender's security interests in the Collateral.

- NOT A CONDITIONAL ASSIGNMENT. Lender and Grantor intend 13. this document to evidence a security interest enforceable against the Collateral as a mortgage and security interest with respect to patents and as a security interest against the trademark registrations. Nothing herein is intended to give rise to a conditional assignment as that term is used in The Clorox Co. v. Chemical Bank, 40 U.S.P.O. 2d 1098 (1996).
- RECORDATION OF AGREEMENT. Grantor hereby acknowledges 14 and agrees that this Agreement shall be recorded with the PTO and the Copyright Office.
- PARTIES BOUND. This Agreement shall be binding on Borrower, 15. Grantor, and their successors and assigns, and shall inure to the benefit of Lender, and its successors and assigns.
- 16. GOVERNING LAW. This Agreement shall be governed by and construed in accordance with the laws of the State of Louisiana.
- INTEGRATION AND CONFLICTS. This Agreement incorporates by 17. reference the terms and conditions of the Loan Documents. To the extent the terms and provisions of this Agreement directly conflict with the Loan Documents, the terms and provisions of the Loan Documents shall govern.
- 18 COUNTERPARTS. This Agreement may be signed in one or more counterparts each of which shall constitute one and the same agreement.


