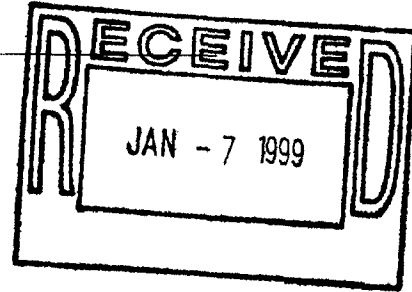

RELEASE OF SECURITY INTEREST - TRADEMARKS

WHEREAS, pursuant to the Agreement, GLOBAL MOTORSPORT GROUP, INC., granted a security interest in favor of the Administrative Agent in the Trademarks (as defined in the Agreement) listed on Schedule A attached thereto;

WHEREAS, the Administrative Agent desires to release its security interest in the trademark registrations and trademark applications listed on Schedule A of Agreement;




