We, Daniel J. That said amendment was duly adopted in accordance with the provisions of K.S.A. 17-6602.

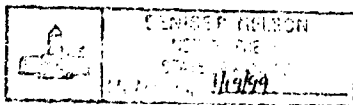


