ASSIGNMENT OF TRADE NAMES AND TRADEMARKS

ASSIGNMENT OF TRADE NAMES AND TRADEMARKS, dated as of October 1, 1998, from Lady Carol Dresses, Inc. ("LCDI"), a New York corporation, Lorac Original Dresses, Inc., a New York corporation, Lady Carol Petites, Inc., a New York corporation, and Carol's Choice Ltd., a New York corporation (the "Sellers") to LCD Acquisition, L.L.C. (the "Purchaser"), a New York limited liability company.

Each of the Sellers, for and in consideration of \$10.00 from the Purchaser delivered to LCDI, and other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, does hereby sell, convey, transfer, assign and deliver to the Purchaser and the Purchaser's successors and assigns all of the Sellers' right, title and interests in and to (i) the trade names set forth on Schedule A annexed hereto (the "Trade Names") and (ii) the trademarks set forth on Schedule B annexed hereto (the "Trademarks"), together with the goodwill of the business of the Sellers in connection with which the Trade Names and the Trademarks are used and which are symbolized thereby.

This Assignment of Trade Names and Trademarks shall also include the right to claim any and all damages by reason of past infringement of the Trade Names and the Trademarks with the right to sue for, and collect the same for Purchaser's own use and enjoyment and for the use and enjoyment of its successors and assigns.

Each of the Sellers agrees and covenants that it shall, from time to time after the date hereof, make, execute, acknowledge and deliver, or cause to be made, executed, acknowledged and delivered, all such further acts, assignments, bills of sale, drafts, transfers of titles and other instruments as counsel for the Purchaser may reasonably request, for the better assigning, transferring, granting, conveying, assuring and confirming to the Purchaser, or to its successors and assigns, or for the aiding, assisting, collecting and reducing to possession any or all of the Trade Names and Trademarks to be assigned to the Purchaser as provided herein.




This Assignment of Trade Names and Trademarks may be signed in one or more counterparts, each of which shall be deemed an original but all of which together will constitute one and the same instrument


