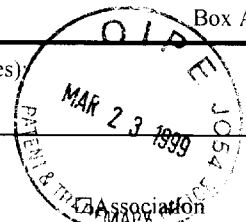

The foregoing sale, assignment and transfer shall include all claims for profits and damages of past infringement, if any, of said United States Trademark and Application for Registration of a Trademark, with the right to sue for and collect the same for the Assignee's own use and advantage and for the use and advantage of its successors, assigns or other legal representatives.
